- 7) Travel expenses, registration fee etc. for Conferences/workshops can be claimed as per the Policy for Personal Development Allowance and reimbursed from the College on submission of the claims. The request should be forwarded to the Principal through the HoD.
- 8) On completion of the project, detailed report of the research work and utilization certificate duly attested by the Chairperson, Dept. RPC shall be submitted within one month of completion of the project.

- 9) All the research works should be translated to visible outcomes in the form of student projects, patents, publications in reputed Journals etc.
- 10) On all publications resulting from the in-house projects, due acknowledgment shall be given to the Management, MBCET, in respect of the funding granted.
