Decision	<p>The Chairman presented a report detailing the actions taken during the Eighth Meeting of the Board of Studies held on 30/04/2025. The Board reviewed the report and noted the progress made.</p>
EE:BS9.03	Considering the 2023 draft Syllabus of S5 and S6 for the B.Tech programme in Electrical and Electronics Engineering.
Decision	<p>The Chairman presented the 2023 draft Syllabus of S5 and S6 for the B.Tech programme in Electrical and Electronics Engineering. The BOS approved the new syllabus with the following suggestions.</p> <p>23EEL30D: Linear Control Systems</p> <p>One of the members expressed concern about the limited number of hours allocated to the final module, which covers controller design. The Chairman clarified that students will be simultaneously attending the Control Systems laboratory sessions, where they will gain hands-on experience in controller design. This practical exposure will complement their theoretical learning and provide them with a comprehensive understanding of the topic.</p>
EE:BS9.04	Considering the 2023 draft Syllabus of S5 and S6 for the B.Tech programme in Electrical and Computer Engineering.
Decision	<p>The Chairman presented the 2023 draft Syllabus of S5 and S6 for the B.Tech programme in Electrical and Computer Engineering. The Board of Studies approved the proposed syllabus with the following suggestions.</p> <p>23EEL31F: Operating Systems</p> <p>The members recommended that this course be designated as a core course for Electrical and Computer Engineering students. The Chairman acknowledged the suggestion and assured that it would be considered during the next curriculum revision.</p> <p>23EEL32C: Advanced Microcontrollers</p> <p>The members sought clarification on the specific microcontroller to be introduced in the course and the inclusion of a lab component. The Chairman informed that</p>



	the syllabus was prepared in consultation with CDAC, and hands-on sessions would be supported by them.
EE:BS9.05	Any other matter with the permission of the Chair.
Decision	<p>The Chairman informed that although the 2020 curriculum was revised in 2022, the open electives offered to students from other branches will continue to be based on the 2020 curriculum, as they are still following that framework.</p> <p>The Chairman further stated that all suggestions made by the Board of Studies members will be communicated to the College authorities and presented at the Academic Council meeting scheduled for 28 May 2025.</p>
