Gist	(a) Chairman called the meeting to order by 02:30 pm. The proceedings began with an invocation.

(c) The Secretary informed that the draft Minutes of the Eleventh Meeting held on 19.06.2024 were circulated through email to all the Members and all the suggestions received were incorporated in the draft Minutes presented in the Agenda Notes. Subject AC12.02	Report on the actions taken/actions pending on the pertinent decisions in the Minutes of the Eleventh Meeting of the Academic Council held on 19.06.2024
Decision	The Academic Council was apprised that actions were initiated on all the pertinent decisions in the Minutes of the Eleventh Meeting held on 19.06.2024 The Action Taken Report was presented. The Council reviewed the report and expressed satisfaction with the progress of the actions taken by the College. Council resolved to approve the Action Taken Report.
Subject AC12.03	Approval of the List of B.Tech Graduands for the year 2024
Decision	Chairman invited the Controller of Examinations to present the complete results and the list of the graduating B.Tech students (Graduands) of the five programmes of the B.Tech 2020-2024 Batch (2020 Autonomy scheme). The Controller of Examinations presented the details using the Powerpoint slides and also tabled the final results and the list of Graduands.
	Academic Council was apprised that 479 students had registered for the final examination, out of which 317 students successfully completed all the curricular requirements and had become eligible for the award of the Degree entitled as Bachelor of Technology (B.Tech) of the affiliating APJ Abdul Kalam Technological University in the respective programmes under autonomy. Council was further apprised that 48 students (across all disciplines) were eligible for the award of B.Tech Degree with Minors, 9 students were eligible for the award of B.Tech Degree with Honours and one student eligible for BTech Degree with both Honours and Minor.
	Chairman also sought permission from the Council to circulate any updates in the results of B.Tech students (2020 admission) after considering the provision for low pass grade.
	Academic Council verified the list and also considered the provisions in the Regulations about the requirements to be fulfilled by each student. Academic Council discussed the matter in detail and resolved to approve the results and the Graduands list of the 317 graduating B.Tech students as all of them had satisfied all the requirements for the award of the Degree.
	Academic Council also resolved to recommend these 317 students to the Governing Body and henceforth to the APJ Abdul Kalam Technological University for the award of the Degree of Bachelor of Technology(B.Tech) in the respective disciplines/programmes by the University.
	Academic council granted permission to circulate the results of B.Tech students (2020 admission) after considering low pass grade.
	Academic Council congratulated the entire team of the College in meticulously conducting the instructions and evaluations which enabled the students to complete the Programmes of study within the stipulated four years duration, viz. 2020 to 2024.
	Chairman apprised the Academic Council about the Convocation to celebrate the graduation of the batch and extended invitation to all the members.
