- 3.5 MBCET considers research as an integral part of the responsibilities of staff members.
- 3.6 The staff members who significantly contribute to quality research and keep high ethics in research undertaken are recognized through faculty promotion schemes and incentives.
- 3.7 MBCET ensures that no use of research or survey methodology or technique violates professional ethics pertaining to the health, safety, privacy, and other personal rights of any human being.

4.0. RESPONSIBILITY

To develop a high-quality research ambiance in the Institute and motivate faculty for research at par with National and international standards, a Research Promotion Committee (RPC) is constituted. The R&D activities in the individual departments are monitored by Department RPC (DRPC) headed by the Head of the respective Department .
