Patron, Manager and Chairman Governing Body of MBCET chaired the Ninth meeting. His Beatitude called the meeting to order by 10:00AM. Meeting was conducted online through GoogleMeet. All Members joined online. The proceedings began as per the following: (a) Meeting was started with a silent prayer led by Chairman. (b) Chairman welcomed the members through a brief note and mentioned about the excellent progress of the College over the years. Chairman specially mentioned about the launch of the Electric Campus Utility vehicle made by the 2023 pass out batch of students of the Mechanical Engineering Department and complimented the Faculty who had mentored them. Governing Body observed that such innovations would be providing motivation for the students and the similar projects could be promoted in more numbers. (c) Minutes of the Eighth Meeting held on 27 March 2023 was read and confirmed GB9.02 Consideration of the Report on the Actions Taken/Actions pending on the pertinent decisions in the Minutes of the Eighth Meeting held on 27 March 2023. Decision Governing Body was apprised that actions were initiated on all the pertinent decisions recorded in the Minutes of the Eighth Meeting held on 27 March 2023 and no actions were pending. Governing Body reviewed the Action Taken Report and approved it. GB9.03 Ratification of the approval of the Results of the M.Tech 2021 Admission Batch (Second Batch of M.Tech under Autonomy) through circulation. Decision Governing Body was apprised that the second batch of M.Tech students under the Autonomy (2021-2023 batch) was admitted in the academic year 2021-2022. Out of the 19 students, 18 students had completed the academic credit requirements in 2023-2024, and had earned the credits required as per the Curriculum: One student discontinued the studies. It was also apprised that the results of this batch were circulated among the Members of the Governing Body, with the kind permission of the Chairman, for advance approval considering the urgency of the need for issuing Grade Cards and the Provisional Certificates to the students for their employment and other purposes. Chairman instructed the Controller of Examinations to present the brief of the final results of the various specializations. The Controller presented the results through powerpoint presentations. After detailed discussions and review, Governing Body approved the final results of the M.Tech 2021 -2023 batch(Semesters I to IV) and ratified the actions taken by the Principal in seeking the approval through circulation. Governing Body approved the name of Mr. H. Aravind Sarma of M.Tech Telecommunication Engineering, who secured the CGPA above 9.0 (CGPA=9.33)., for the award of the Certificate of Merit and the Gold Medal of

Decision	Governing Body was apprised that in the M.Tech 2021-2023 batch there were 18 (Eighteen) students who had fulfilled all the requirements of the Master of Technology(M.Tech) Degree Programme and had become eligible for the award of the Degree of Master of Technology(M.Tech) of the affiliating APJ Abdul Kalam Technological University, in the respective disciplines/ specializations. Chairman instructed the Controller of Examinations to present the list of the eligible students of the various specializations of the M.Tech 2021-2023 batch. Controller of Examinations presented the details using the powerpoint slides and also tabled the verified Graduands' list.

The Examinations were conducted offline during 08.08.2023 to 21.08.2023, after a preparatory leave. 17 students appeared for the examination (CS - 2, CE SE- 7, CE TRE-5, EE -1, MD - 2) Chairman instructed the Controller of Examinations to present the results of the Examinations. Controller gave a detailed presentation and the analysis of the results as well through online presentations. After detailed discussions, Governing Body approved the results without any moderation and granted permission for the publication of the results. The results of the Coursework of the Ph.D Scholars were also approved.

	It was also informed that the Results were published with due permissions. Principal sought ratification of the action taken and also requested the approval from the Governing Body for the results of the Supplementary Examinations conducted after the Eighth meeting of the Governing Body.

GB9.10	Consideration of the implementation of the new Curriculum for the B.Tech Programmes with effect from the Academic year 2023-2024 onwards	
Decision	Governing Body was apprised that College had undertaken a revision of the Curriculum of all the seven B.Tech Programmes in the year 2023-2024 to bring in significantly useful features for helping the students to get a better learning experience. It was apprised that the overall credit requirements for B.Tech Degree would be 163 in which 160 credits had to be earned through the academic activities and 3 credits through the co/extra academic activities. More details in this regard would be formulated by the College to guide the students. Also that the options for Minor Degree and Honours were retained as in the

existing curriculum, however the credit requirements for Minor and Honours were tentatively kept as 15 each and this would be finalized after knowing the affiliating University's new framework in 2024-2025 or so.

Governing body reviewed the features of the proposed Curriculum of the seven B.Tech Programmes and granted the approval for implementing the new curriculum in the academic year 2023-2024. Following were the seven B.Tech Programmes for which the new curriculum. The approved intake for 2023-2024 would be as shown against each Programme:

- 1. B.Tech Civil Engineering (120 seats)
- 2. B.Tech Computer Science and Engineering (120 seats)
- 3. B.Tech Computer Science and Engineering(Artificial Intelligence) (60 seats)
- 4. B.Tech Electronics and Communication Engineering (120 seats)
- 5. B.Tech Electrical and Computer Engineering (60 seats)
- 6. B.Tech Electrical and Electronics Engineering (60 seats)
- 7. B.Tech Mechanical Engineering (90 seats)

Governing Body instructed that if the statutory approvals from any agency including the APJ Abdul Kalam Technological University was required to be obtained by the College the same should be done to avoid any legal entanglements for the College as an autonomous institution.

Discussions on the Institutional Development Plans and the identification of Strategies, Resources and the Mobilization Plans and the Implementation thereon

Decision

Principal apprised the Governing Body about the need for re-positioning the College in respect of the Vision, Mission and Goals so as to take the College to the higher level of excellence and sought time for a detailed discussion. Chairman directed that College should prepare a blueprint of the action plan and conduct initial discussions internally pursuant to which Governing Body would consider it for the review and possible approval.

Governing Body, however, appreciated the pace of progress of the College since its inception in 2002 and especially the improvements made after becoming autonomous in 2020. Governing Body congratulated the entire team of the College in the efficient management and the excellent reputation being maintained. Governing Body directed that College should aim at introducing a variety of Programmes and Courses in line with the NEP 2020 so that the College would be immune to the market trends and the institutional growth would be very robust in terms of enrollment, research, innovations, startups, etc. College could also look into stronger industrial collaborations and national/international institutional networking in the coming years to get ranked in the national and international institutional rankings.
